ORDER

The Syndicate resolved, vide paper (2) read above, to remind the
affiliated colleges the following:

“Educational agency of every educational institution shall satisfy the
following before the commencement of the academic year 2010-2011.

1. The land and building of the institution shall be earmarked
exclusively for the purpose of the college concerned and each
affiliated institution shall have independent facilities and shall not be
shared with any other institution.
2. The infrastructural facilities, faculty, experimental set up etc. shall be
provided as per the requirement of the courses conducted in
accordance with the norms/guidelines, stipulated by the regulatory
body concerned and the University.
3. Copy of the land documents showing the ownership in the name of
the Trust/Society/Management running the institution, recently
issued non-encumbrance certificate etc. shall be properly
maintained.

In case of institutions fails/lacks to maintain the above, the same shall
be rectified/fulfilled prior to the admission process for the academic year
2010-11.

All unaided Institutions shall submit the details of their teaching staff in
the proforma appended (Appendix I, II & III), on or before June 30,
2010.”
