It is hereby notified that election will be held to the following posts of the MGU Union, 2008-'09 by and from among the members of the General Council of the MGU Union, 2008-'09 in accordance with the system of proportional representation by means of single transferable vote as provided under Rule 21(2) of the bye-laws of the Mahatma Gandhi University Union for students:

1. Chairman	One
2. Vice-Chairman	Three(one shall be a Lady)
3. General Secretary	One
4. Joint Secretary	Two
5. Member, Executive committee	Fifteen (3 shall be ladies)
6. Member, Accounts Committee	Five

Only those persons whose names are on the Electoral Roll published for the purpose are eligible to take part in the election. The Electoral Roll is prepared on the basis of the details of the councillors forwarded by the Principals / Directors of the respective colleges / Institutions where elections are held as per University directives. Every elector shall refer the Electoral roll and point out the mistakes, if any, within the time stipulated in this regard.

Every elector shall be at liberty to nominate a qualified person to fill up each vacancy. Nominations in the prescribed form shall be deposited in the Box provided for the purpose in the Election Section or sent to the Returning Officer(in sealed covers) so as to reach him on or before the last date and hour fixed. Separate nomination papers should be submitted for each vacancy. Nomination papers will be issued to the electors free of cost, on application, from the office of the Returning Officer (Election section).

No elector shall propose or second more names than there are vacancies for a particular post. Every nomination shall be proposed by an elector with his / her signature and seconded by another elector with his / her signature. The candidate shall sign a declaration on it expressing his / her willingness to serve on the body, if elected.

Any candidate may withdraw his / her candidature by notice in writing signed by him / her and sent by Registered Post or delivered in person or through messenger to the Returning Officer, so as to reach him within the date and hour fixed for withdrawal. Withdrawal once made shall be final.

Polling and scrutiny & counting of votes will be conducted in accordance with the provisions contained in Part C-procedure for election without postal Ballot of Chapter 44 of the M.G.U statutes, 1997.

No person other than the candidate or his / her authorised agent shall be permitted to be present at the time of scrutiny of Nominations, Polling and Scrutiny and Counting of votes.

The Identity cards issued from the University should be produced on the above occasions and while turning up for voting. Duplicate Identity cards will not be issued on the date of Poll.

The electors shall strictly follow the instructions relating to their conduct during the scrutiny of nominations, Polling and scrutiny and counting of votes, issued separately.
