ELECTION TO THE SENATE AND STUDENTS COUNCIL OF THE MAHATMA GANDHI UNIVERSITY BY THE GENERAL COUNCIL OF THE UNIVERSITY UNION, 2008-09.

It is hereby notified that elections will be held to fill up the vacancies in the Senate and the Students' Council vide item (12) under the heading 'Elected Members' in Section 17 and item (a) under the heading 'Elected Members' in Section 29 (2) respectively of Chapter IV of the MGU Act 1985, in accordance with the system of proportional representation by means of single transferable vote.

I. SENATE – SECTION 17 – Elected Members (12)

Fifteen members elected by the members of the General Council of the University Union from among full-time students, of whom one shall be a PG student, one shall be a Research Scholar, one shall be a student of professional college, five shall be Lady Students, one shall be a member of a Scheduled Caste and one shall be a member of a Scheduled Tribe.

II. STUDENTS' COUNCIL –SECTION 29 (2) – Elected Members (a)

Fifteen members, not being members of the Senate or the Academic Council, elected by the members of the General Council of the University Union from among themselves, of whom five shall be women and two shall be members of a Scheduled Caste or a Scheduled Tribe.

Only persons whose names are on the electoral roll published on 4.8.2009 are eligible to take part in the election and to vote thereat subject to the provisions contained in the statutes. Every elector is at liberty to nominate one duly qualified person to each seat. Every such nomination shall contain the consent of the nominee agreeing to serve on the body, if elected.

Nominations shall be made in the prescribed form, copies of which can be had from the Election Section. Nomination paper should reach the undersigned not later than 1 P.M. on 27.8.2009, and the envelope containing Nomination paper should be superscribed "Election to the Senate/ Students' Council – Nomination paper".

Candidates contesting for reserved seats should attach copies of certificates, attested by a Gazetted Officer, to prove their eligibility to be elected to that particular seat. Certificate issued by the Tahsildar is required to prove caste.
